Ecuador is located in South America and has a population of nearly 18 million. The capital city of Ecuador is Quito which has a population of 1.9 million. Ecuador was named after the equator which runs through the country, the only country in the world named after a geographical feature. Its official name, República del Ecuador, literally means "the Republic of the Equator".

When negotiating terms of an employment contract and offer letter with an employee in Ecuador, it may be useful to keep the following in mind:

Employment Contracts in Ecuador

In Ecuador, employment contracts can be oral or written, but it is best practice to put a strong, written contract in place, in Spanish, which spells out the terms of the employee's compensation, benefits, and termination requirements. An offer letter and employment contract in Ecuador should always state the salary and any compensation amounts in American Dollars rather than a foreign currency. The employment contract template is part of the service with Globalization Partners; no need to draft a separate template if you use our employer of record and PEO service in Ecuador.
